

# Energy storage 2025 subsidies

Will energy storage grow in 2023?

Global energy storage's record additions in 2023 will be followed by a 27% compound annual growth rate to 2030, with annual additions reaching 110GW/372GWh, or 2.6 times expected 2023 gigawatt installations. Targets and subsidies are translating into project development and power market reforms that favor energy storage.

Will China install 30 GW of energy storage by 2025?

In July 2021 China announced plans to install over 30GW of energy storage by 2025 (excluding pumped-storage hydropower), a more than three-fold increase on its installed capacity as of 2022.

Will US-made battery energy storage systems become cost-competitive in 2025?

US-made battery energy storage system (BESS) DC container solutions will become cost-competitive with those from China in 2025 thanks to incentives under the Inflation Reduction Act (IRA), Clean Energy Associates said. The solar and storage technical advisory firm revealed the forecast in its new quarterly BESS Price Forecasting Report for Q3 2023.

Will battery energy storage investment hit a record high in 2023?

After solid growth in 2022, battery energy storage investment is expected to hit another record high and exceed USD35 billion in 2023, based on the existing pipeline of projects and new capacity targets set by governments.

Is India ready for battery energy storage in 2022?

The Inflation Reduction Act, passed in August 2022, includes an investment tax credit for stand-alone storage, promising to further boost deployments in the future. In its draft national electricity plan, released in September 2022, India has included ambitious targets for the development of battery energy storage.

How much money will be allocated to storage projects in 2023?

Residential batteries are now the largest source of storage demand in the region and will remain so until 2025. Separately, over EUR1 billion (\$1.1 billion) of subsidies have been allocated to storage projects in 2023, supporting a fresh pipeline of projects in Greece, Romania, Spain, Croatia, Finland and Lithuania.

Applicants must pledge to complete their energy storage investments by the summer of 2025. The Government expects to announce the winning applicant by the end of this year. The scheme aims to support the addition of 146 MWh of storage capacity to the network by the end of May 2025, double the capacity

under construction at present.

Through at least 2025, the Inflation Reduction Act extends the Investment Tax Credit (ITC) of 30% and Production Tax Credit (PTC) of \$0.0275/kWh ... Energy storage is eligible if “connected to” the solar or wind project. The requirements are: Projects must be less than 5MW AC; Requires allocation by Treasury -Capped at 1.8 GW DC per year;

In May 2023, Maryland became the 11th and latest state to enact an energy storage target, with a goal to deploy 3 GW of storage capacity by 2033. The new law requires the Maryland Public Service Commission to establish the Maryland Energy Storage Program by July 1, 2025 and provides for incentives for the development of energy storage.
