Are energy storage codes & standards needed?

Discussions with industry professionals indicate a significant need for standards..." [1,p. 30]. Under this strategic driver,a portion of DOE-funded energy storage research and development (R&D) is directed to actively work with industry to fill energy storage Codes &Standards (C&S) gaps.

What if the energy storage system and component standards are not identified?

If relevant testing standards are not identified,it is possible they are under developmentby an SDO or by a third-party testing entity that plans to use them to conduct tests until a formal standard has been developed and approved by an SDO.

Do energy storage systems need a CSR?

Until existing model codes and standards are updated or new ones developed and then adopted, one seeking to deploy energy storage technologies or needing to verify an installation's safety may be challenged in applying current CSRs to an energy storage system (ESS).

Does industry need standards for energy storage?

As cited in the DOE OE ES Program Plan,"Industry requires specifications of standardsfor characterizing the performance of energy storage under grid conditions and for modeling behavior. Discussions with industry pro-fessionals indicate a significant need for standards ..." [1,p. 30].

Does energy storage need C&S?

Energy storage has made massive gains in adoption in the United States and globally,exceeding a gigawatt of battery-based ESSs added over the last decade. While a lack of C&S for energy storage remains a barrier to even higher adoption,advances have been made and efforts continue to fill remaining gaps in codes and standards.

Do electric energy storage systems need to be tested?

It is recognized that electric energy storage equipment or systems can be a single device providing all required functions or an assembly of components,each having limited functions. Components having limited functions shall be testedfor those functions in accordance with this standard.
