NGK Insulator and Fluence accounted for the second- and third-largest market shares.

What is the future of energy storage?

Renewable penetration and state policies supporting energy storage growth Grid-scale storage continues to dominate the US market, with ERCOT and CAISO making up nearly half of all grid-scale installations over the next five years.

What is the growth rate of industrial energy storage?
