

# Energy storage planning for 2025

Why was the energy storage roadmap updated in 2022?

The Energy Storage Roadmap was reviewed and updated in 2022 to refine the envisioned future states and provide more comprehensive assessments and descriptions of the progress needed (i.e., gaps) to achieve the desired 2025 vision.

Will China install 30 GW of energy storage by 2025?

In July 2021 China announced plans to install over 30 GW of energy storage by 2025 (excluding pumped-storage hydropower), a more than three-fold increase on its installed capacity as of 2022.

Will new energy storage be more expensive in 2025?

The NDRC said new energy storage that uses electrochemical means is expected to see further technological advances, with its system cost to be further lowered by more than 30 percent in 2025 compared to the level at the end of 2020.

How can energy storage be used in future states?

Target future states collaboratively developed as visions for the beneficial use of energy storage. Click on an individual state to explore identified gaps to achievement. What is the future of energy storage?

When will new energy storage development be introduced?
