



# Nassau new energy storage project bidding

Is the Bahamas ready for a sustainable future?

The Prime Minister said the choice The Bahamas faces is stark. "Continue down a path of expensive, unreliable energy or pivot towards a future where energy is sustainable, affordable and secure." He noted that this Government administration's number one focus is reducing the cost of living for every Bahamian.

Does New Providence need a solar grid?

An interactive, two-way grid is required given any grid-connected distributed solar or renewable energy, however, he added. "Studies have shown that the New Providence grid (which serves Nassau) can take at least 8 megawatts (MW) of solar without worrying about storage.

How much energy does New Providence use?

New Providence's energy consumption totals around 260 MW, according to a local news report.
