

How can energy storage help save Britain's energy costs?

By capturing and storing excess renewable energy, which is now the cheapest form of electricity, storage can help keep energy costs from spiralling, and power Britain's homes with 24/7 renewable clean energy.

Can new energy storage technologies boost UK energy resilience?

However, new energy storage technologies can store excess energy to be used at a later point, so the energy can be used rather than wasted - meaning we can rely even more on renewable generation rather than fossil fuels, helping boost the UK's long-term energy resilience.

How will a new funding program help energy storage developers?

The UK government is launching a new funding program to unlock investment in long duration storage, a key part of its drive to optimize the expansion of renewable energy. Under the so-called cap and floor regime -- already used for electricity interconnectors -- energy storage developers will be guaranteed minimum revenues.

How can energy storage improve our energy resilience?

Accelerating renewables is key to boosting our energy resilience. Energy storage helps us get the full benefit of these renewables, improving efficiency and helping drive down costs in the long term.

Is long-term energy storage a good idea?

Julian Leslie, Director & Chief Engineer National Grid ESO said: "Integrating long duration energy storage into the grid is going to be vital to delivering the UK's long term energy strategy. Our recent Future Energy Scenarios report shows that 4GW of liquid air storage will be required over the coming decades.

How will government funding help Green Innovators in the UK?

This £32.9 million government backing will enable green innovators across the UK to develop this technology, helping create new jobs and encouraging private investment, while also safeguarding the UK's energy security. The funding announced today follows the first phase of the LODES competition, which saw £2.7 million awarded to 19 projects.

Renewable energy investor Copenhagen Infrastructure Partners (CIP) has confirmed that its 500MW/1,000MWh battery energy storage system (BESS) in Scotland, UK, is ready to commence construction.
