Why was the energy storage roadmap updated in 2022?

The Energy Storage Roadmap was reviewed and updated in 2022 to refine the envisioned future states and provide more comprehensive assessments and descriptions of the progress needed (i.e., gaps) to achieve the desired 2025 vision.

What is the future of energy storage?

Storage enables electricity systems to remain in balance despite variations in wind and solar availability, allowing for cost-effective deep decarbonization while maintaining reliability. The Future of Energy Storage report is an essential analysis of this key component in decarbonizing our energy infrastructure and combating climate change.

Why is energy storage important?

Energy storage is a potential substitute for, or complement to, almost every aspect of a power system, including generation, transmission, and demand flexibility. Storage should be co-optimized with clean generation, transmission systems, and strategies to reward consumers for making their electricity use more flexible.

Can energy storage be a single high-level resource?

This report summarizes over a decade of experience with energy storage deployment and operation into a single high-level resource to aid project team members, including technical staff, in determining leading practices for procuring and deploying BESSs.

Investigating the potential for energy storage in the UK. The project was conceived in early 2016, when Harmony Energy made a leap of faith into the energy storage sector. As a company, we had a strong belief that the energy storage market in the UK was fundamental to the country's ambitions to decarbonise.

The UK currently has more than 13.5GW of battery storage projects in the pipeline, with 1.3GW ready to build, 5.7GW with planning permission and a further 6.5GW proposed. The solar industry has welcomed the move to exempt large-scale energy projects from the national planning scheme. Planning laws had threatened to stifle a nationwide battery boom.

The proposed project, Valley Center Energy Storage, consists of a Site Plan (STP) to construct a battery energy storage system (BESS) facility capable of delivering 140-megawatts (MW) for a 4-hour period and associated improvements (Project).
